All accounts are due and payable at the remittance address shown on the Alaska Steel invoice. Applicant agrees that each of the terms and conditions of sale stated on the Alaska Steel invoices shall be a term of the contract of each sale from Alaska Steel to Applicant. Applicant acknowledges that monthly service charge at the maximum legal rate, but not to exceed 1.5% per month, (18% per annum), shall be made on all sums due to Alaska Steel which have not been paid within thirty (30) days from the invoice date, and the Applicant agrees to promptly pay said service charges. The service charge will be due and payable on the thirty-first (31st) day after the original invoice date, and an additional service charge, computed. Applicant further agrees that with regard to such service charges, Applicant and Alaska Steel are parties to a written contract. If Alaska Steel commences litigation or employs attorneys in order to secure payment of any sums due to it from Applicant, the Applicant agrees to pay reasonable attorney fee's in addition to all other sums due.
